



ADMINISTRATIVE DECISION APPEAL INFORMATION

WHAT IS AN ADMINISTRATIVE DECISION APPEAL?

An appeal is an opportunity to contest a permitting decision made by the Benton County Planning Manager. All decisions made by the Planning Manager are appealable to the Benton County Hearings Examiner.

THE PROCESS

No later than fourteen (14) days following the mailing of the written decision of the Planning Manager, the decision may be appealed to the Hearings Examiner. After a completed Appeal form is submitted, the Planning Division shall notify the applicant and all interested parties that an appeal has been filed. An open record appeal hearing will be scheduled and a written notice of the hearing shall be mailed to the appellant and all interested parties. Notice of the hearing shall be published in the newspaper at least ten days prior to the appeal hearing.

The Hearings Examiner shall review the written appeal, the record of the decision and receive written and/or verbal public testimony at the open record appeal hearing. After reviewing the record and any testimony presented, the Hearing Examiner shall either, deny the appeal and affirm the Planning Manager's decision; or amend, reverse, or remand the Planning Manager's decision. The Hearings Examiner shall enter findings of fact and conclusions of law in support of the decision.

APPEALS

The Planning Manager's decision may be appealed to the Benton County Hearings Examiner within fourteen (14) days following the issuance of the decision.
