

Sergeant/Corporal testing is scheduled for March 17th & 18th. And the Evidence Tech testing happened on February 18th – one candidate passed and is on the list.

She reminded them that the rules were adopted at the February meeting, but they had chosen to move forward with updating the grammar for the Sergeant qualification. This has since been done.
