

RESOLUTION

WHEREAS, Chapter 39.34 of the Revised Code of Washington permits local governmental units to make the most efficient use of their powers by enabling them to cooperate with other localities on a basis of mutual advantage; and

WHEREAS, it is in the best interests of Benton County to enter into an Inter-local Cooperative Purchasing Agreement with Adams County to facilitate the purchase of goods and services,

NOW, THEREFORE, BE IT RESOLVED that Ron Jones, Chairman Protem of the Board of County Commissioners, Benton County, Washington, be authorized to sign the Inter-local Cooperative Purchasing Agreement with Adams County on behalf of Benton County.

INTERGOVERNMENTAL COOPERATIVE PURCHASING AGREEMENT

Pursuant to Chapter 39.34 RCW and to other provisions of law, Adams County and the following named municipal corporation, hereby agree to cooperative governmental purchasing subject to the following terms and conditions:

- (1) Benton County in contracting for the purchase of goods and services agrees to contract also on behalf of Adams County to the extent permitted by law and agreed upon by the parties.
- (2) Benton County will contract for the purchase of goods and services according to the laws and regulations governing purchases by and on behalf of Benton County. Adams County accepts responsibility for compliance with any additional or varying laws and regulations governing purchases by Adams County.
- (3) Whenever Benton County has contracted to purchase goods or services on behalf of Adams County, Adams County may purchase goods and services covered by the contract on the same terms and conditions as Benton County. Such a purchase by Adams County to the vendor or other party contracting to furnish goods or services to Benton County. Benton County accepts no responsibility for the performance of any purchasing contracts by the vendor and accepts no responsibility for the payment of the purchase price by Adams County.
- (4) Adams County reserves the right to contract independently for the purchase of any particular class of goods or services, with or without notice to Adams County.
- (5) Benton County reserves the right to exclude Adams County from any particular purchasing contract, with or without notice to Adams County.
- (5) This Agreement shall continue in force until cancelled by either party, which cancellation may be effected with or without notice to the other party.
- (7) This Agreement is for Benton County contracts that are agreed upon by both parties.
